Terms and Conditions

Please read these terms and conditions carefully before using Our Service.

Rental of olive tree

- The rental contract is concluded when the tenant purchases the package included in the rental offer on the website (3-5-10 year rental period)
- 2. During the rental period, the lessor is obliged to take care of the olive tree, harvest the olives, process the harvested olives and bottle the olive oil in metal cans. If the lessee requests glass bottling, the cost of bottling is not included in the rent. The cost of bottling will be invoiced separately. The cost of postal delivery is not included in the rental price and will be invoiced separately.
- 3. Harvesting starts in November each year. Each year the tenant receives the finished olive oil after the harvest (November to March).
- 4. The average yield of olive oil per olive tree per year is 8-10 litres. The lessor is not responsible for any loss of crop due to weather conditions and is only obliged to deliver as much olive oil as can be produced from the quantity of olive oil produced in the year.
- 5. The landlord undertakes not to charge the tenant any other expenses during the rental period.
- 6. The rental contract expires on the turn of the rental start date.

 The rental contract can only be renewed by concluding a new rental contract at the current prices.
- 7. If the tenant terminates the contract during the rental period, the rent paid will not be refunded. After termination, if the tenant is still entitled to olive oil, the landlord will deliver it to the tenant every year.
- 8. The lessor agrees that the lessee may resell the olive oil to third parties.
- 9. In the event of a dispute, the parties will seek an amicable solution, and if this is not possible, they will stipulate the jurisdiction of the Florence court.

Interpretation and Definitions
